

RULES FOR RENTAL OF WATERMARK HOMES

All Applications for rental/lease should go to Vesta
Rentals periods shall not be for less than 6 months
A home cannot be rented/leased more than twice per calendar year
Applications must be received by Vesta not less than 45 days in advance of rental start date
\$100 application fee and \$500 escrow deposit to accompany application
New FOB's and Car stickers will be issued for each rental
Background checks will be conducted.
It is the landlord's (owners) responsibility to inform renters of all Rules and Regulations and Vesta should receive a sign-off indicating that has been done.
Landlords must make it clear to renters that they are the first point of contact for questions, concerns, etc. NOT the management company. Repeat calls to the management company, rather than the landlord, will result in a \$50 fine after the first contact.
